advertises the following call for applications pursuant to Section 20/A of Hungary's Act XXXIII of 1992 on the Status of Public Employees for the position of **full professor** at Eötvös Loránd University, Faculty of Informatics, Institute of Computer Science, Department of Programming Languages and Compilers

Duration of the public employee status: indefinite duration

Type of employment: part-time

Place of employment: 1117 Budapest, Pázmány Péter sétány 1/C.

Primary responsibilities of the position:

Internationally recognized teaching and research in the field of programming languages, functional and parallel programming, program refactoring.

Contributing to the scientific research work, publication and project application activities in the department.

Development of international relations, supervision, encouragement of talent management.

Salary:

The provisions of Act XXXIII of 1992 on the Status of Public Servants shall apply to the determination of salary and benefits.

Required professional qualification:

- PhD degree,
- habilitation or an equivalent international higher education experience, the equivalence of which will be investigated by the faculty habilitation committee, (in case of internal applicant it is not required if the habitus investigation has already been done by the faculty habilitation committee),
- professional experience (university full professor) above 5 years at a university which is full member of the European Association for Quality Assurance in Higher Education (or another institution qualified by an ESG-compliant accreditation organization).

Documents and certificates to be attached to the application:

- Curriculum Vitae of the candidate
- The professional and research plans of the candidate
- Certificates of professional degrees, academic degrees
- Bibliography of published works
- In the case of successful application, an official Certificate of Good Standing no older than three months (not required in the case of an internal applicant).
